VALLEY CENTER FIRE PROTECTION DISTRICT RESOLUTION 2022-56

RESOLUTION TO IMPLEMENT TELECONFERENCING REQUIREMENTS DURING A PROCLAIMED STATE OF EMERGENCY UNDER GOVERNMENT CODE SECTION 54953.

WHEREAS, the Ralph M. Brown Act requires that all meetings of a legislative body of a local agency be open and public and that any person may attend and participate in such meetings;

WHEREAS, the Brown Act allows for legislative bodies to hold meetings by teleconference, but imposes specific requirements for doing so;

WHEREAS, on March 17, 2020, in order to address the need for public meetings during the present public health emergency, Governor Newsom issued Executive Order No. N-29-20, suspending the Act's teleconferencing requirements; and

WHEREAS, on June 11, 2021, Governor Newsom issued Executive Order No. N-8-21, continuing the suspension of the Brown Act's teleconferencing requirements through September 30, 2021; and

WHEREAS, these Executive Orders allowed legislative bodies to meet virtually as long as certain notice and accessibility requirements were met; and

WHEREAS, the State Legislature amended the Brown Act through Assembly Bill No. 361 (AB 361) on September 16, 2021; and

WHEREAS, AB 361 amended the Brown Act so that a local agency may use teleconferencing without complying with the regular teleconferencing requirements of the Act, where the legislative body holds a meeting during a proclaimed state of emergency and makes certain findings; and

WHEREAS, Government Code section 54953 requires that the legislative body make additional findings every 30 days in order to continue such teleconferencing.

NOW THEREFORE, the legislative body of the Valley Center Fire Protection District hereby finds, determines, declares, orders, and resolves as follows:

Valley Center Fire Station 1 28234 Lilac Road Valley Center, CA 92082 Valley Center Fire Station 2 28205 N. Lake Wohlford Road Valley Center, CA 92082

- 1. That the foregoing recitals are true and correct and incorporates them by this reference.
- 2. The Board of Directors of the Valley Center Fire Protection District (District) finds, by a majority vote, the following:

a. That there exists a proclaimed state of emergency; AND either:

- b. The Board of Directors of the Valley Center Fire Protection District is meeting for the purpose of determining one of the following, or more than 30 days have passed since the Board met and determined one of the following and the Board now re-determines one of the following:
 - i. State or local officials have imposed or recommended measures to promote social distancing; OR
 - ii. As a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.

OR

- c. This Board of Directors has made the determination set forth in subdivision (b), above within the last 30 days and now makes the following determination:
 - i. The Board of Directors of the Valley Center Fire Protection District has reconsidered the circumstances of the state of emergency; AND
 - ii. Any of the following circumstances exist:
 - 1. The state of emergency continues to directly impact the ability of the members to meet safely in person.
 - 2. State or local officials continue to impose or recommend measures to promote social distancing.
- 3. The District Fire Chief or his designee is authorized to take all steps and perform all actions necessary to execute and implement this Resolution in compliance with Government Code section 54953.
- 4. That this Resolution shall take effect immediately upon its adoption.

A proposal was made for Consideration to Approve Resolution NO. 2022-52 continuing to Implement Teleconferencing Requirements During a Proclaimed State of Emergency Under Government Code Section 54953. After motion made and seconded and a roll call vote, Resolution 2022-52 was unanimously approved by the Board.
- 5. Public Comment None
- Proclamations and Presentations There was a presentation made by Robin Biglione, Biglione Construction and Nathan Complin, Erickson-Hall Construction to update the Board on the progress of Station 3 and the Renovations at Stations 1 & 2. The Board expressed concerns regarding the project timeline.
- Consent Calendar The consent calendar, containing the minutes from the Special Meetings September 8, 2022 and October 6, 2022, Regular Meeting September 15, 2022 and Resolution NO 2022-55 (Santee Ln) on Intention to Annex Territory to CFD 2008-1, after motion made and seconded, and a roll call vote, was approved unanimously by Directors O'Connor, Roberts, Seaborne, Bell and Hutchison.

8. Staff Reports

A. Fire Chief's Report – Chief Napier presented the month's activities.

- B. Operations Division Report was also presented by Chief Napier.
- C. Fire Station Project Monthly Update was presented earlier in the meeting by Robin Biglione and Nathan Complin.
- D. Community Risk Reduction Division Report Chief Napier gave the Fire Marshal's report in Chief Davidson's absence.
- E. Valley Center Firefighters Association Report Captain Chris Palmer reported for the Valley Center Firefighters Association. The Association is in the process of creating a new website that will have a more professional presence and will be a resource for members to access the MOU and other documents as well. They are also redesigning their logo. The crews participated in the Great Shakeout, a great event for members to get out there to their assigned schools and see what goes on during an incident. The Association will be donating money to the Susan G. Komen breast cancer three day walk. They are looking for other ways to reach out to the community.
- Old Business A proposal was made to adopt Resolution NO. 2022-50 approving The Center For Public Safety Excellence 2022 Community Driven Strategic Plan. After a short discussion, a motion was made and seconded and a roll call vote Resolution 2022-50 was unanimously approved.

10. New Business

- A. The Board held a Public Hearing on an Annexation Petition into CFD 2008-1. After the hearing, upon motion duly made and seconded, and a roll call vote, Resolution NO. 2022-53 (Cole Grade) and Resolution 2022-54 (Park Circle) were approved unanimously by the Board.
- B. The second reading and adoption of Ordinance 2022-62 enacting The 2022 California Fire Code And The 2021 International Fire Code With Certain Amendments, Additions And Deletions was held. After motion made and seconded and a roll call vote, Ordinance 2022-62 was unanimously approved by the Board.
- 11. Treasurers Report The Treasurer's Report was presented by Director Seaborne, she had a question about the utilities at the stations which has been resolved because we are now ready to operate on solar. Director Seaborne made a motion to approve the Treasurer's Report, which was seconded by Director Roberts, the Treasurer's Report was approved unanimously by a roll call vote of the directors.

Director Bell announced after the closed session that the Board voted to retain the services of Liebert, Cassidy & Whitmore and gave direction to them to respond to a demand letter from a personnel matter.

Director Roberts thanked Director Seaborne for asking about the utilities, that's really good news. She is astounded at how wonderful the District is and the great work we are doing. Great job, Chief, on the strategic plan and the team's process. Director O'Connor didn't have anything, but good job to Chief, staff and firefighters. Director Seaborne said it was good to be back with the group. Echoes Director Roberts and Director O'Connor about the quality work that the team continues to do. Great job on

RESOLUTION 2022-58 CFD 2008-1 – ANNEXATION PALOS TIERRA RD 185-420-10-00



RESOLUTION NO. 2022-58 A RESOLUTION OF INTENTION OF THE BOARD OF DIRECTORS OF THE VALLEY CENTER FIRE PROTECTION DISTRICT TO ANNEX TERRITORY TO COMMUNITY FACILITIES DISTRICT NO. 2008-1 AND TO AUTHORIZE THE LEVY OF SPECIAL TAXES THEREIN

WHEREAS, under the Mello-Roos Community Facilities Act of 1982, as amended (the "Act"), Chapter 2.5 of Part 1 of Division 2 of Title 5, commencing at section 53311 of the California Government Code, the Board of Directors (the "Board") of the Valley Center Fire Protection District (the "District") has conducted proceedings to establish Community Facilities District No. 2008-1 (the "CFD"), and

WHEREAS, the Board is the legislative body for the CFD and is empowered with the authority to annex territory to the CFD and now desires to undertake proceedings to annex territory to the CFD, and

WHEREAS, a petition requesting institution proceedings to annex territory to Community Facilities District No.2008-1 District has been received from landowners owning not less than 10% of the proposed land to be annexed to the CFD, and

WHEREAS, the petition dated November 7, 2022 has been found to meet the requirements of Government Code section 53319, and

WHEREAS, this Board, having received indications of interest from the owner of the areas of land proposed to be annexed to the CFD, now desires to proceed with the annexation to the CFD in order to finance the balance of the costs of certain public services and facilities necessary or incident to development in the CSD.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Valley Center Fire Protection District as follows:

1. This Board hereby finds and determines that public convenience and necessity require that territory be added to the CFD be formed and that the Board is authorized to conduct proceedings for the annexation of territory to the CFD pursuant to the Act.

2. The name of the existing CFD is "Community Facilities District No. 2008-1."

3. The territory included in the existing CFD is as shown on the map thereof filed in Book 42 of Maps of Assessment and Community Facilities Districts at Page 27 in the office of the County Recorder, County of San Diego, State of California to which map reference is hereby made for further particulars. The territory now proposed to be annexed to the CFD is as shown on Annexation Map No.2 to the CFD on file with the Clerk of the Board, the boundaries of which territory are hereby preliminarily approved and which map is incorporated in full herein by reference. The Clerk of the Board is hereby directed to record, or cause to be recorded, said map showing the territory to be annexed to the CFD in the office of the County Recorder of the County of San Diego within fifteen days of the date of adoption of this Resolution.

4. The types of services financed by the CFD and pursuant to the Act consist of those services (the "Services") described in Exhibit A to Resolution 2008-09, adopted by the Board on May 29, 2008 (the "Resolution of Formation"). It is presently intended that the Services will be shared, without preference or priority, by the existing territory in the CFD and the territory proposed to be annexed to the CFD.

5. Except to the extent that the funds are otherwise available to the CFD to pay for the Services, a special tax sufficient to pay the costs thereof is intended to be levied annually within the CFD and collected in the same manner and at the same time as ordinary *ad valorem* property taxes. The proposed rate and method of apportionment of the special tax among the parcels of real property within the CFD, as now in existence and following the annexation proposed herein, in sufficient detail to allow each landowner within the territory proposed to be annexed to the CFD to estimate the maximum amount such owner will have to pay are described in detail in Exhibit A attached to the Resolution of Formation, which by this reference is incorporated herein.

6. The Board shall hold a public hearing (the "Hearing") on the annexation of territory to the CFD and the proposed Rate and Method of Apportionment at 6 p.m., or as soon thereafter as practicable, on December 15, 2022, at the Valley Center Municipal Water District, at 29300 Valley Center Road, Valley Center, California. At the hearing, the Board will consider and finally determine whether the public interest, convenience and necessity require the annexation of territory to the CFD. Should the Board determine to annex territory to the CFD, a special election will be held to authorize the levy of the special tax in accordance with the procedures contained in Government Code section 53326. If held, the proposed voting procedure at the election is expected to be a landowner vote with each landowner of record as of the close of the Hearing having one vote for each acre of land or portion thereof owned within the territory to be annexed to the CFD. Ballots for the special election may be distributed by mail or by personal service. At the time and place set forth above for the Hearing, any interested person, including all persons owning lands or registered to vote within the proposed CFD, may appear and be heard.

7. The District may accept advances of funds or work-in-kind from any source, including, but not limited to, private persons or private entities, for any authorized purpose, including, but not limited to, paying any cost incurred by the District in the annexation of territory to the CFD. The District may enter into an agreement with the person or entity advancing the funds or work-in-kind, to repay all or a portion of the funds advanced, or to reimburse the person or entity for the value, or cost, whichever is less, of the work-in-kind, as determined by this Board, with or without interest.

8. The District Secretary is hereby directed to cause notice of the public hearing to be given by publication one time in a newspaper published in the area of the CFD. The publication shall be completed at least seven days before the date of the public hearing in Section 6. The Secretary shall also cause notice of the hearing to be given to each property owner within the CFD by first class mail, postage prepaid, to each such owner's addresses as it appears on the most recent tax records of the District or as otherwise known to the Secretary to be correct. Such mailed notice shall be completed not less than fifteen days before the date of the public hearing. Each of the notices shall be substantially in the form specified in section 53322 of the Act, with the form summarizing the provisions hereof hereby specifically approved.

9. Except as may otherwise be provided by law or by the rate and method of apportionment of the special tax for the CFD, all lands owned by any public entity, including the United States, the State of California and/or the District, or any departments or political subdivisions thereof, shall be omitted from the levy of the Special Tax to be made to cover the costs and expenses of the

Services and the CFD. In the event that a portion of the property within the CFD shall become for any reason exempt, wholly or in part, from the levy of the special tax, this Board will, on behalf of the CFD, increase the levy to the extent necessary upon the remaining property within the CFD that is not exempt in order to yield the required revenues to pay for the Services and other annual expenses of the CFD, if any, subject to the provisions of the rate and method of apportionment of the special tax.

10. The officers, employees and agents of the District are hereby authorized and directed to do any and all things and to execute and deliver any and all documents which they may deem necessary or advisable in order to carry out, give effect to and comply with the terms and intent of this resolution.

The purpose of the meeting was to provide an update on the ongoing design work.

Temporary Fire Station No. 3

Brandon provided the following design updates:

- Following the kick off meeting with the VCMWD, Water District staff reviewed the meter at the Harmony Grove Fire Station and indicated that it is not acceptable and that an in line meter will be required to measure the flow to the on-site fire hydrant.
- The Civil Engineer is incorporating comments from VCMWD into the Civil plans.
- The Electrical Engineer is working on specifying the required generator size. Generators under 50HP (approx. 37 KW) will not require a permit from SDAPCD.

Remodel Work at Station 1 and 2

The Mechanical Engineer visited Station 1 and 2 on Friday, November 4, to collect additional data on existing conditions.

Temporary Fire Station No. 3

During the past month design work on the Temporary Fire Station No. 3 site included:

Accounts were set up with the County and Valley Center Municipal Water District to pay fees for the agencies to review the septic system and the water system plans, respectively.

The septic design was submitted to the County on October 19, 2022, and the review time is currently four months. The approval is anticipated by February 19, 2023.

The final SDG&E design is progressing ahead of schedule and coordination with AT&T will begin soon.

A kickoff meeting was held with Valley Center Municipal Water District on November 2, 2022. They provided valuable feedback on water system design, which the Civil Engineer is incorporating into the plans.

A slight adjustment to the location of the automated gate was made to accommodate site topography. This adjustment will also provide additional space for the trucks to pull off the road before entering the site.

There was discussion of the size and type of emergency generator. A propane generator was requested. The electrical engineer is working on specifying the required emergency generator size to adequately power the temporary trailers, automated gate and the canopy for truck parking.

Design Progress on Station 1 and 2 Remodel Work

The design sub consultants have been working on plumbing, mechanical and electrical drawings for the remodel work. The mechanical engineer visited the sites on November 4, 2022, to collect additional data.

Next Steps

- 1. Erickson-Hall will continue working on the estimate of probable cost.
- 2. Detailed design work on the civil and architectural drawings for all three locations will continue.
